### **General Public Comment**

- A. Jim Thompson asked if the board wanted to set up a meeting with RTMA to discuss the water purchase rate for 2018. It is in the water purchase contract to have a meeting before the rate is set for that year.
- B. Randy Westover asked what GVMA will do with customers that haven't tapped into the system. He also asked about properties that are using the sewer but not the water. The solicitor will address these issues.
- C. Kate Mahlon asked if we have a copy of the judge's order from our hearings with RTMA so that they could review it.
- D. Chuck Johns asked how many customers we have lost, because RTMA claims they needed to raise rates to cover customers they have lost. He also said that the two boards should work together to come up with a long term water purchase agreement.
- E. John Krise asked why the bids for contractors for the year aren't done at the first of each year. They are always done in the early spring. He also asked about the sewer usage rate increase.
