- K. Rick Gates made a motion to retroactively approve Requisition #16 in the amount of \$5,229.00. Jim Krause seconded the motion. A vote was taken. Tom Roles abstained due to his employment with Keller's. All other board members voted aye. Motion passed.

- L. Tracy Plessinger made a motion to approve Requisition #17 in an amount not to exceed \$115,000.00. Rick Gates seconded the motion. A vote was taken. Tom Roles abstained due to his employment with Keller's. All other board members voted aye. Motion passed.
- M. Rick Gates made a motion to amend the agreement between the GVMA and White Township as presented by the township secretary. Jim Krause seconded the motion. A vote was taken. All board members voted aye. Motion passed.

- **A.** Randy Westover had a question about whether a grinder pump would work for a property on Baker Road. It would be the homeowner's grinder pump-the GVMA would not be responsible for maintenance of it.
- **B.** John Krise asked if the park model on the property at 119 Hill Street is being billed. It is being billed with the owner's adjacent home, and will be required to tap into the sewer system separately.
